Draw conduct

- 1. The number of sold tickets will be verified on the Jumbo Lottery Platform through a draw reconciliation report generated from the platform.
- 2. Once the entry list is validated the list will be uploaded to the RNG.
- 3. A ticket number will be drawn by clicking the "Draw winner" button on the RNG.
- 4. The RNG will show the winning ticket number and ticket status.

A Jumbo team member will prepare the reconciliation report and entry list containing all ticket numbers for the draw and will conduct the draw by clicking the draw winner button on the RNG. An additional team member will review and verify the number of sold tickets and ticket number list independently against the Jumbo Lottery Platform to ensure all draw details are accurate and oversee and validate the draw.

Draw supervision
