I refer to the Jumbo Interactive submission dated 25 May 2021 regarding the Drawmaster v1.1 program software.

The Office of Liquor and Gaming Regulation (OLGR) has evaluated the program software under the Random Number Generator (RNG) Minimum Technical Requirements v1.5.

Please note that the scope of the evaluation performed by OLGR has been confined solely to the RNG and associated sections of the Drawmaster v1.1 program relating to seeding, scaling, mapping, usage of the RNG and compliance to the technical requirements for Category 3 draws.

As no issues were found during the course of the evaluation, approval of the RNG and associated program (**attachment 1**), for the Queensland jurisdiction is granted under the *Charitable and Non-Profit Gaming Act 1999*.

Special Conditions

1. The Drawmaster system is approved for use with category 1, 2, 3 and 4 draws conducted under the *Charitable and Non-Profit Gaming Act 1999*.
2. Drawmaster can be used for draws with a maximum prize value of \$5,000,000.
3. The Win Chance parameter must not be used for draws conducted under the *Charitable and Non-Profit Gaming Act 1999*.


